

8. CAPITAL PROJECT

A Regular Meeting of the Board of Education of the Belleville Henderson Central School District (the "District") held in the School Library, 8372 County Route 75, Adams, New York on October 16, 2017, at 7:00 o'clock P.M. (Prevailing Time).

RECITAL

WHEREAS, the District, is a local agency pursuant to the New York State Environmental Quality Review Act ("SEQRA"), ECL Section 8-0101, et seq., and implementing regulations, 6 NYCRR Part 617 (the "Regulations"); and

WHEREAS, the District is considering undertaking a capital improvement project consisting of renovations and improvements to the District's pre K-12 School Building, Bus Garage and athletic fields, including, but not limited to, HVAC improvements, roof replacement and athletic field reconstruction (the "Project").

NOW THEREFOR, BE IT RESOLVED by this Board of Education as follows:

Section 1. The District's Board of Education has reviewed the potential impact of the Project upon the environment, as required by the Regulations and by resolution adopted September 27, 2017 determined that the Project is an Unlisted Action as defined in SEQRA and that the Project will not result in any significant adverse impacts to the environment.

Section 2. A Special Meeting of the qualified voters of the Belleville Henderson Central School District, County of Jefferson, State of New York, will be held in the School Foyer of the Belleville Henderson Central School located at 8372 County Route 75, Belleville, New York on December 7, 2017 from 2:00 P.M. to 8:00 P.M., prevailing time, for the purpose of voting on the proposition described in the Notice of Special District Meeting hereinafter set forth.

Section 3. The business to be acted upon at said Special District Meeting shall be as stated in the Notice thereof, and the District Clerk is hereby authorized and directed to cause the Notice of said Special District Meeting to be published in the Watertown Daily Times and the South Jeff Journal, newspapers having a general circulation within the District, such publications to be made four (4) times each in such newspaper within the seven (7) weeks next preceding such Special District Meeting, the first publication to be at least forty-five (45) days prior to the date of said Special District Meeting.

THE BOARD OF EDUCATION OF THE BELLEVILLE HENDERSON CENTRAL SCHOOL DISTRICT HEREBY GIVES NOTICE that pursuant to a Resolution adopted by the Board of Education of the District on October 16, 2017, a special meeting of the qualified voters of said School District, County of Jefferson, State of New York, will be held in the School Foyer at the Belleville Henderson Central School Building located at 8372 County Route 75, Belleville, New York on December 7, 2017 from 2:00 P.M. to 8:00 P.M., prevailing time, for the purpose of voting upon the following proposition:

PROPOSITION I

(Capital Project)

Shall the Board of Education make renovations and improvements to the pre K-12 School Building, Bus Garage and athletic fields, all of the foregoing to include related site work, utilities, mechanical, plumbing and electrical, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work and expend therefore a total sum not to exceed \$2,750,000 which is estimated to be the total maximum cost thereof, and pay for the costs of the Project by using (i) available State building aid, (ii) \$950,000 from the District's 2008 Capital Reserve and (iii) to the extent necessary, the levy of a tax which is hereby voted in the amount of \$1,800,000, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$1,800,000, and a tax is hereby voted to pay the interest on said obligations when due.

PROPOSITION II

(Reserve Fund)

Shall the Board of Education be authorized to establish a new ten-year reserve fund pursuant to section 3651 of the Education Law in the amount of \$4,000,000 to be used for the acquisition of machinery and equipment for and the construction and reconstruction of improvements and additions to all District buildings, grounds and facilities, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2018 and each fiscal year thereafter, (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, (iv) the balance on June 30, 2018 of the District's old 2008 capital reserve fund and (v) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law.

NOTICE IS GIVEN that voting upon the foregoing Proposition will be by ballot and will take place in the School Foyer at the Belleville Henderson Central School Building located at 8372 County Route 75, Belleville, New York on December 7, 2017 from 2:00 P.M. to 8:00 P.M., prevailing time.

NOTICE IS FURTHER GIVEN that qualified voters may obtain applications for absentee ballots from the office of the Clerk of the School District. Completed applications for absentee ballots must be received by the District Clerk of the School District no later than 4:00 p.m. prevailing time, on December 6, 2017 and must be received no later than 4:00 p.m., prevailing time, on November 30, 2017, if the absentee ballot is to be mailed to the voter. Completed applications received after 4:00 p.m. on November 30, 2017 will require the voter to personally appear at the Office of the Clerk of the School District to receive an absentee ballot. A listing of all persons to whom an absentee ballot is issued will be available for inspection by any qualified voter in the Office of the Clerk of the School District between the hours of 9:00 a.m. and 4:00 p.m. through December 6, 2017 except Saturdays, Sundays or holidays.

NOTICE IS FURTHER GIVEN that the proposition set forth on the ballot shall appear as follows:

PROPOSITION I

(Capital Project)

Shall the Board of Education make renovations and improvements to the pre K-12 School Building, Bus Garage and athletic fields, all of the foregoing to include related site work, utilities, mechanical, plumbing and electrical, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work and expend therefore a total sum not to exceed \$2,750,000 which is estimated to be the total maximum cost thereof, and pay for the costs of the Project by using (i) available State building aid, (ii) \$950,000 from the District's 2008 Capital Reserve and (iii) to the extent necessary, the levy of a tax which is hereby voted in the amount of \$1,800,000, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$1,800,000, and a tax is hereby voted to pay the interest on said obligations when due.

PROPOSITION II

(Reserve Fund)

Shall the Board of Education be authorized to establish a new ten-year reserve fund pursuant to section 3651 of the Education Law in the amount of \$4,000,000 to be used for the acquisition of machinery and equipment for and the construction and reconstruction of improvements and additions to all District buildings, grounds and facilities, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2018 and each fiscal year thereafter, (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, (iv) the balance on June 30, 2018 of the District's old 2008 capital reserve fund and (v) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law.

WHEREAS, Section 119-n of the General Municipal Law defines the term "municipal corporation" for the purposes of Article 5-G as a county outside the city of New York, a city, a town, a village, a board of cooperative educational services, a fire district or a school district; and

WHEREAS, Belleville Henderson Central School District (hereinafter sometimes referred to as "Participant") is a "municipal corporation" as defined above; and

WHEREAS, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

NOW THEREFORE, BE IT RESOLVED, that this Board hereby determines that it is in the interests of the Belleville Henderson Central School District to participate in

BE IT FURTHER RESOLVED, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

BE IT FURTHER RESOLVED, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

WHEREAS, Belleville Henderson Central School District (hereinafter sometimes referred to as "Participant") is a "municipal corporation" as defined above; and

WHEREAS, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May, 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

NYSMEC NATURAL GAS

NOW THEREFORE, BE IT RESOLVED, that this Board hereby determines that it is in the interests of the Belleville Henderson Central School District to participate in the NYSMEC, and authorizes and directs the Superintendent of Schools to sign the Agreement/and or the Billing Schedule and Agreement for natural gas on its behalf; and

BE IT FURTHER RESOLVED, that this Board authorizes the Administrative Participant (as defined in the Agreement) to prepare, advertise, disseminate and open bids pursuant to the General Municipal Law and to award, execute and deliver binding contracts on behalf of this Board for the purchase of natural gas delivered to the city gate of the local utility distribution company for the Participant's facility or facilities, on a firm basis, for this Participant to the lowest responsible bidder as is determined by the Administrative Participant at a price for such commodity natural gas not to exceed \$1.134 (dollars) per term for a term of at least one year and no more than three years commencing May 1, 2018, and other terms and conditions, all as may be determined by the Administrative Participant, or to reject any or all such bids; and

BE IT FURTHER RESOLVED, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

BE IT FURTHER RESOLVED, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

This Resolution shall take effect immediately.
