

PRESENTATIONS

Pam Halloran and Michael Crowley from Crowley and Halloran COAs, P.C. presented to the Board, their findings for the 2023 audit. The audit received an unmodified opinion, which is the highest opinion allowed. They reviewed their findings and answered any questions that the board had.

They also reviewed the findings of the independent audit, requested by the Board of Education April of 2023 for a review on the Capital Reserve Account established in 2008 and budget transfers occurring between the general fund's unassigned fund balance and Capital Reserve Account. The independent audit was requested by the Board of Education in response to a Freedom of Information Law (FOIL) received by the Business Office, requesting information on the Capital Reserve Account. After extensive document gathering and research, Crowley and Halloran's findings were that all money has been accounted for and used on the Capital Project.

Ms. Collins added that she was very satisfied with the very through audits and the findings for each audit.

NEW BUSINESS

6. RESOLUTION AUTHORIZING COMMENCEMENT OF SOCIAL MEDIA LITIGATION WHEREAS, in recent years, it has become apparent that children and teenagers are spending an inordinate amount of time scrolling through various social media

platforms, including Meta, Instagram, TikTok; and

WHEREAS, while spending time on social media platforms, children and teenagers are often subjected to harmful and exploitative content which is causing them to experience increased anxiety, depression, and other mental health issues at an alarming rate; and

WHEREAS, studies have shown that as a result of increased mental health issues secondary to social media use, students are performing worse in school, are less likely to attend school, are more likely to engage in substance use and to act out somewhat violently, all of which affects a school district's ability to fulfill its educational mission; and

WHEREAS, the Belleville Henderson School District Board of Education ("BOE") has been invited to join a nation-wide lawsuit by public entities, including many school districts, against Meta, TikTok, Snap, and YouTube as well as other social media companies; and

WHEREAS, the lawsuit alleges that these social media companies have caused a mental health crisis among children and teenagers that severely affects their ability to succeed in school; and

WHEREAS, the BOE wishes to join this lawsuit to hold social media companies accountable for their exploitive conduct, send the message to these companies that profits should not be prioritized at the expense of children's health and safety, and provide the District with financial resources to mitigate this ongoing mental health crisis.

NOW, THEREFORE, BE IT RESOLVED, that the Belleville Henderson School District Board of Education hereby resolves:

- To appoint the law firm Frantz Law Group, APLC to provide legal services in connection with pursuing claims for damages associated with the litigation against Meta, TikTok, Snap, and YouTube as well as other social media companies consistent with the recitals above;
- 2. To approve the contract for such legal services; and
