WHEREAS, the Board of Education of the Belleville Henderson Central School District (the "Board" or "District") employs staff who are not represented by a recognized employee organization pursuant to the New York State Public Employees' Fair Employment Act ("Non-aligned Employees"); and

WHEREAS, the Non-aligned Employees do not have collective bargaining agreements and, therefore, have their terms and conditions of employment established by action of the Board of Education; and

WHEREAS, on March 15, 2020, Governor Andrew Cuomo issued Executive Order 202.4, which mandates that effective March 17, 2020 through April 15, 2020, the District must allow non-essential personnel to be able to work from home or take leave without charging accruals, except for those personnel essential to the District's response to the COVID-19 emergency; and

WHEREAS, the District was ordered close by a declaration of a local state of emergency on March 18, 2020.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to New York General Municipal Law Section 92, New York Education Law Section 1709(16), and Executive Order 202.4, the Board shall provide paid leave to all non-essential, non-aligned employees on regularly scheduled workdays, at their regular rates of pay, who are ready, willing and able to work as determined by the Superintendent of Schools from March 18, 2020 through the period that Executive Order 202.4 remains in effect and any period that extends the effect of Executive Order 202.4; and

BE IT FURTHER RESOLVED, all essential personnel who are ready, willing and able to work, as determined by the Superintendent of Schools, shall perform such duties within the scope of their title during the period that Executive Order 202.4 remains in effect, including any prior school closures, and any period that extends the effect of Executive Order 202.4 whether remotely and/or in the District.

President Allen: At this time I will entertain a motion.

NOW, THEREFORE, BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby approves and/or ratifies the termination of the Inter-Municipal Cooperation Agreement ("Agreement") for legal services

with the Jefferson-Lewis-Hamilton-Herkimer-Oneida Board of Cooperative Educational Services ("BOCES"), entered into on or about July 15, 2019, effective sixty (60) days after written notice is provided to BOCES as provided for in paragraph 11 of said Agreement;

AND BE IT FURTHER RESOLVED, that the Board of Education hereby approves and/or ratifies the provision of written notice to BOCES by the Superintendent of Schools of the termination of said Agreement and legal services.

Superintendent Collins: Thank you JW.

ADMINISTRATIVE REPORT(S)

NYSED Required COVID-19 Plans - Under the Governor's Executive Order every school district submitted three plans as a condition of school closing. These are: The Continuity of Learning Plan, the Child Care Plan and the School Food Service Plan.

Page 11 of 13

Continuity of Learning - On Tuesday, March 17, 2020, students learning packets went out to homes across the district. Last week, teachers began making a shift to technology instructional techniques and working closely with Scott and Ashleigh on these approaches.

- a) **Food Service Distribution Plan** Meal counts have increased from 130 students to 202 students participating. Every student is getting breakfast and lunch Monday through Saturday. This week 2,424 meals were distributed.
- b) **Child Care for Essential Workers** Our Child Care Plan for parents of Essential Workers is through the Watertown YMCA School Aged Child Care Program. The YMCA will provide emergency childcare for school-age children at 10 sites and at the YMCA Daycare in Watertown for daycare-aged children. Only children of workers in healthcare, emergency services and other Essential personnel are eligible to participate in the emergency childcare.

Food Pantries - Thanks to Watertown Urban Mission, the Bellleville Henderson Communities have temporary Food Panties. Thanks to the efforts of Mary Forrester, Colleen and Mike Bellinger, Rusty Corron, and Jay Canzonier, we have been able to establish two temporary local Food Pantries using government surplus foods. Mary and her husband used Jay's refrigerated truck to pick up the food and distributed it to the Belleville Henderson Fire Department where Rusty's family helped Mary and her family unload the food. They also delivered food to Colleen's Cherry Tree Ice Cream Shop. Mr. Adam Miner has secured a donation of Cheese sticks for the Food Pantries from a local farmer. Henderson Fire Department could not extend an offer to host the pantry and Mr. and Mrs. Bellinger stepped up to support this worthy cause. Marcie Matthews and Rebecca Eastman are providing support to these two sites on M, W, and F from 10 AM to Noon. The Belleville Fire Department opened the pantries last Saturday from 12 to 5 PM. These food pantries are open to anyone who is in need of food.

Flattening the Curve - The Governor's Executive Order is very clear that only "Essential Personnel" are allowed to be at school during this pandemic. Food Service Workers and custodians are Essential Personnel. Transportation workers are Essential Personnel. Non-Essential personnel are those persons who do not have to be at school to do their job, like teachers, administrators, and CSEA persons who are not needed to perform an essential duty at school. All non-essential personnel have been directed to either work from home or wait to be called to report for another duty at school.

Continuity of Learning - Teachers are working from home and reaching out to students and parents using technology and phones. Our teachers have been working together and with the support of Mr. Storey and Mrs. Barnhart-Burto and the Jefferson Lewis BOCES to create and establish virtual classrooms. This past week we deployed 150 Chromebooks out to 150 students who express through a parent survey that they needed these devices to complete their school work and to be able to work with their teachers online and through distance learning.

NYS ELA and Math Assessments were cancelled due to COVID-19 Pandemic.

Today the NYSED and Chancellor Rosa announced that the Regents will be cancelled this year.

School Election and School Budget - The Election and School Budget Vote has been pushed out to June 1, 2020 by the Governor's Executive Order. We are awaiting further details from the NYS Education Department on these timelines given the change in dates.

State Aid - On April 1, 2020, NYS Legislators approved a budget for 2020-2021. We are awaiting further guidance on how to precisely to interpret this information.

That completes my report.

Adam Miner: The only thing I would say is we have a voucher system setup for milk at the two food pantries now too. People who need milk can just get a voucher at the food pantry go to Farm Pride and get a gallon of milk.

Superintendent Collins: That's great thank you Adam. That is excellent.

President Allen: Any other any other questions or feedback for Ms. Collins? At this time are there any generic questions that need to be researched? I know the question is when will we meet again? I believe that is to be determined unless we are going to stick with the April 20th date. Ms. Collins or Sally can you answer that?

Superintendent Collins: I recommend that not make a decision to meet on the 21st unless we need to meet for budget purposes what we need to wait and see what the calendar is for the June 1st deadline and then we could announce the next board meeting if that's okay with the Board.

President Allen: That is okay with me and I just wanted everyone to hear that. So we will have to continue to see these updates from Jane, hourly, daily. We will do what we have to do, the meeting could be sooner or it could be later.

Superintendent Collins: Yes.

President Allen: I think the most important thing right now is that we all stay health and safe. I know a handful of us are essential. Follow the guidelines that you see the Vice President hold up all the time. We can all be a part of this ending sooner rather than later. I also think in closing, there is no executive session, there are no items for discussion. I would like to say in closing, thank you all for joining us, I know it was a little bit of a rough start, but next time we have this we should be that much farther ahead. I also want everyone to remember that the most important thing we can do is to remain unified, remain positive. Remember that the number one priority of us all the time is the safety of our students faculty and staff and that is more so apparent today

than ever. I also think that if we remain together and remember our mission, vision and goals we can overcome this. Things are going to be different going forward, but if we can remain positive and provide the best infrastructure whether it be the meals or education. The situation we are in [unreadable]. What Ashleigh just did is the most import thing, kiss the little ones. I think we will end on a happy note then folks. Thanks again for joining us.
