President Allen: I'm going to give the second to Kyle. You jumped in first for the second by Kyle. Any discussion? What a nice gesture. As well on this topic what a nice gesture that Jane and our teams, Scott, Ashelgh, Kim Fingar. I missing someone? I missed Karen Bertram, went around to highlight our seniors. It's a very nice gesture. No more discussion. All in favor, by a show of hands (all six raised their hand). That motion is carried 6-0.

President Allen: There's no policy. For the Board's review, a letter from Kathy Sidmore, in regards to Graduate's Association Banquet, which we know the governor has issued all public schools to remain closed through June

30th. So there are no events going on. Thank you for recognizing that and sending a letter of appreciation. We also got a letter from Grace Rice regarding the supporting the local BOCES budget. We will jump into Jane's report if everybody could be muted at turn this over to Jane at this time.

Ms. Collins: Good evening JW, I'm going to pick up on what you said regarding school has been closed by the governor and basically what that means is that teachers and students will not be coming back to school for the remainder of the school year. However, classes continue until the end of June, until the end of the school year. So we've informed the parents of that, and the students that it's not the school years over. It's just that we won't be going to school at school. In terms of the school calendar, we have Memorial Day where there is no school. However, some people have asked what about May 22. The rules of the Governor's Executive Order, state that we will be in session on Friday, May 22nd. So we are not altering our schedule to be closed, we will be open May 22 but closed March 25 (misspoke should be May 25th) Memorial Day.

Administration Mr. Storey and Mrs. Barnhart-Burto have been looking at the End of the Year Activities. While there are some activities that we will not be able to have like Grandparents' Day unfortunately because that is a gathering and the Yearbook Assembly because that is a gathering and the parades that the band marches in, we won't be able to participate in because there won't be parades and those are all gatherings. The senior picnic is a gathering. So unfortunately those are all programs that we will not be able to have this year.

But there are end of the year activities that Mr. Storey and Mrs. Barnhart-Burto are working on and what are going to do about:

- Pre-K Celebration
- The awards program for K-2
- Students in grades 3-5
- Students in grade 6
- The 7-12 awards program
- Athletic Banquet with the Boosters

So these are things that we are working on and we want the Board to know and the community that we are looking at how can we recognize students.

Graduation: We had a meeting today with the County Officials. Bob Hagemann and the county, and with the Jefferson County public health and again, it looks like a graduation now it's going to be leaning towards something. That does not involve getting together socially. We have to continue the social distancing and the gathering for the June activities, that's all June activities.

So are looking into how can we recognize is great senior class that's lost so much of their year through some virtual program and we will be getting to the community, the board, and the students more on that that meeting was just this afternoon at 2:30.

Summer school at the end of May the Governor said he would make a statement about whether or not we will have summer school. And I think at this point in time, if we have summer school, it's going to look like a virtual

summer school. I will say this, I think we have to do some work on what that would look like because there are a number of people that are saying, they are ready for a break. Parents working with children at home, a virtual summer school might be a challenge. Teachers, I'm not sure what their opinion is of this yet, but we want to look at summer school and how we could do something for the kids and it might not.... It doesn't look like it's going to be in person, summer school, but again on May 29th, the Governor is going to make that call.

What about reopening in September? Well, we need to wait and see what happens about that, but we are starting to plan for contingency plans, and if we have students in September, we would have to look at that through social distancing lens where, and again as time gets closer to September will have a plan but we're working on that.

What about our budget? Well, I just wanted to go through a couple of things about the budget. The of course, some increases in the budget this year are due to salary increases.

We also know that there are stringent protocols coming out about how disinfecting of schools will need to look. So, we have a whole lot of work to do to plan that way and we know that if we have kids in the school in September, we're going to need an additional cleaner to help us keep that those areas disinfected wherever people are during the day and then following the school day to clean up at the end of the school day. We also know that if we have to keep kids apart by six feet, we have to come up with [unreadable] educate students and would that mean part time? So that means some school students would come to school every other day. We're looking at that. What we know is well distance on a school bus.

A sixty passenger school bus would only hold [unreadable] we to be able to maintain that six feet distance. So, if we were to bring in students, we'd have to do multiple runs. So we've [unreadable] additional salary costs for transportation because of additional runs.

Another area that is increased the budget going to be the debt payments and that's due to the 2017 capital project as well, as the BOCES capital project.

The last thing to talk about regarding the budget is that in the 2019-2020 school year, we purchased one bus in the 2020-2021 school year we will be purchasing two busses, one large plus in one small. The small bus will be wheelchair accessible and an additional cost more than what a normal small bus would be.

I just want to complement our, our teachers and all the great work that they're doing and our cleaners and our transportation department, and our clerical people, and our food service department. We have more families and ever participating in the meals and they're just not knocking it out of the part, the food service department and what they're providing to families. And a big shout out to all those people who are participating in the food pantries. Our food pantries had fifteen additional new people on Saturday come. We have donations now coming from a bakery to the food pantry, and we've had multiple two times now, when gallons of milk have been donated by different parties. So, we really are doing a great job for families out there and a lot of people are helping with that and keeping that going. So the community is getting behind that and working together.

We're doing to come together and be panther strong. That concludes my report.

President Allen: I appreciate everything your team is doing, and I think you summed it up well, there still continuing to be a team effort by everybody in our district.

Shout out to the parents too and I know it's not an easy task for a lot of the working parents. We are [unreadable] new life and dealing with what we are given at this time? Are there any questions for Jane or her report specifically her to her report?

Adam Miner: Any idea of what percentage of students we hear absolutely nothing from?

Ms.Collins: We are, we are communication with all the students. Every Friday teachers report to the administrators on the students that have not participated in their Google meetings, and that they have not personally talk to or talk to their parents. Then there are regular meetings following that during the week where the Principal and the Counselors and Psychologist and Mrs. BB go through that list and families are contacted so we, you know, we have been in touch with everybody. And we continue to be vigilant on that.

President Allen: Good question.

Adam Miner: Steve can you just send us an updated summary, like the presentation on the 9th of how exactly the budget breaks down?

Stephen Magovney: Yep, I can do that.

Adam Miner: Thank you.

Kristin Vaughn: Will, classes for the 7-12, still end the middle of what do they end middle of June, or in the middle of May or June right before they do the testing and stuff?

Ms. Collins: We are, we are awaiting correspondence from [unreadable] on the end of the school year, and all of that ties into the Executive Order where he said to us, that any unused snow days, any vacation days will become part of what the Executive Order includes and he's directed all schools to continue to participate in providing lessons to students. I know that at the state level, there's a correspondence, there's NYSSBA and the New York State [unreadable] organization. Both are communicating with the Governor's Office [unreadable] the calendar year will, or when classes will end and so yeah.

President Allen: You mentioned NYSSBA, one thing I'd want it noted, and I read the article this weekend Governor Cuomo has developed. [unreadable] we educate. Are you familiar with that Jane? But I seen that NYSSBA had no representation on it. Two organizations we belong to NYSSBA and Rural Schools, nobody was represented on what a traditional classroom should look or a new classroom looks like one. Haven't initially when all this was going down this was very proactive. I haven't heard from them in probably a month.

Jane Collins: I will, you know, I, I can reach, I can reach out to NYSSBA and find out where they are with that, because I would be surprised if they haven't already reached out to them on that and said you know we need to be on this board or this committee.

President Allen: Other questions for Jane on her report?

Adam Miner: Just remember your governor is not very smart JW because the only North Country Representative on, this reopen New York thing is the President of JCC.

President Allen: So, yeah, and this wasn't in regards to reopening.

Adam Miner: The same thing. Nothing.

President Allen: Yeah, I'll dig the article, but yeah. Same idea. Roger has a question.

Roger Eastman: Question, Jane maybe Scott, I think we need to be careful on the Chromebooks with younger K through 6, because they're getting some of the Google Meets are going too long and starting to affect some of the kids seeing and stuff. So, I just want to advise the teachers maybe, you know, fifteen to twenty minutes at the most, and some kind of a break and come back. Because I took my son to the doctor the other day, because he was concerned that he wasn't able to see the sheets or the numbers on the screen. But doctor said, there's, there's too much screen time. You can't go that period of time and keep focus and then go off that, go to something else. Read out of the book is just not. It's not good to look at. So, I just want to put that up.

Ms. Collins: Thank you. Roger. We talked about it since, since you spoke to me, I have talked to the administrators and we have meetings with teachers. We can go over that with them.

Roger Eastman: Thank you.

President Allen: Are there questions or concerns?

Adam Miner: Is there any is, I mean, you brought it up, so basically there's no, we're looking at any avenues to do anything for graduation other than something like this. Drive up, stay in your car, anything, basically nobody wants to touch any of it.

Ms. Collins: Anything that's going to promote a gathering is what we heard today that they do, you know, we can't do. It's like we already cancelling parades because people stand along the road and gather to watch the parade. The fairs the concerts, all of these activities have been cancelled because of the gathering. That was pretty much the message that I took away. And then we, Steve attended the meeting, Scott and Ashley and then we met afterwards, and those were all part of our interpretations of what was said.

So, we are, we are trying to we're going to look at what [unreadable] virtual production where we do a really good job representing all that our kids are and what they have been during their high school times.

You know what I saw clearly concerned from Bob when we met, is the new childhood. COVID and what we heard from public health about public gathering is be very careful, because we are not out of the woods with this yet and could be we don't want to create the conditions so that we can't keep moving in this direction and then we're going to be back doing the same thing in September. I don't know Scott Ashley, Steve, if you want to chime in on any more that we talked about afterwards, you're welcome to.

President Allen: On that note, though, when so it is May 11th when will when will the meeting like that be held again with the County Executives, local Superintendents? Do know Jane is there another meeting, before June 1st.

Ms. Collins: There is not another one with accounting executives. My request of the group was to have the County Executives to create protocol for school districts and Public County said they would create protocols as well. But it I personally asked the County to create protocol so that we could all be on the same place. I didn't get an answer on that. There was a lot of silence after that. But I'm going be pressing that at the Superintendent's level and there wasn't another meeting of the county set up but I do know a neighboring district had all these things planned and basically we're told they couldn't do them.

President Allen: When is your next superintendents meeting?

Ms. Collins: We have them every week, so this week.

President Allen: You're still having weekly? Okay.

Ms. Collins: We have at least one.

President Allen: Adam, did you have something?

Adam Miner: Yeah, I mean right if they're going to shut everything down all the way through summer, there's no way we're going to go back in September. There's no way they're going tell you, you can't do a single thing all summer and then say, September, you can go back to congregating everybody. So if nobody's willing to try anything? I read articles about other schools, using drive in movie theaters, carving cars, twenty feet apart, do a short presentation or something right? I mean, if nobody is willing to discuss it at all, we're all screwed.

President Allen: I don't think she's saying that we're opposed to that. We've got to do something virtually. So is it through a movie theater type thing where, you know, you and you're graduate and their family stay in your vehicle? That's what we need to explore we've got from now until June 30th to figure it out. I mean, Oswego Speedway I mean, they are, you know, 30-40 minutes from here, they're not in our district they offered, all Oswego County Public Schools to utilize your race track to hold a graduation. So maybe your students are featured in the grandstands, and all of anybody who wants to participate graduation goes around the, the race track. Daytona International has done that for example. I think we have to be creative and whatever we do. I mean, I think the bottom line is that we're not going meet, we're not going hold graduation the auditorium, right, there's probably no way. But between all of us, we're going celebrate and honor our graduates one way or the other and that's what we need to remember. How are we going to do that? What does that look like? We've got an administration that's going figure that out and then the Board's going to have to have input because, this is something we're all passionate about we're going to and I, and I'm not saying anybody here said that we are not saying one way or the other, we're going to honor recognize our students because they deserve to be. How do we do that? Public Health says we can get together in a soccer field, stay six feet apart that we need to think of something that we can do make it work.

Adam Miner: Basically the way I took the whole conversation we had was the only thing that's going to happen is some remote video online based on the account, the comments from the county. So that's the way I took it.

Ms. Collins: Well, in Adam, right now, because we just had the meeting at 2:30 today and, you know, none of us created this situation, we're trying to figure it out and without putting anybody in harm's way, that's the bottom

line. It certainly is not to be a policing of anything it's to, like, just figure out how to get everyone through this and keep everyone safe. You know, Public Health explained.....

President Allen: When do you think we will be able to meet person?

Ms. Collins: I don't know. [unreadable] got any word on that. Once I do, I'll be more than happy to let everybody know. It's one of those things that you can't predict.

President Allen: You were about to say Public Health explained?

Ms. Collins: Public Health, they talked about, you know, these other examples that people talked about another states, and basically New York, is the only state that isn't seeing a rise in COVID. All these other states have doing these activities that are contributing to the rise in COVID. That was today's presentation. I think that's what we're trying to keep a handle on is to keep this going down and at the same time, not be an expert on COVID, but well, we're all doing a great job in New York state and it's all the COVID cases are going down, deaths are going down at the same time, you know, we're doing the social distancing and then you see the other states opening up, and the curve is going up the curve is coming down. I know that the shift today on the news with the Governor that it's going from being coming from his office now to a regional shift. The regional Scott Grant is our local presentative on that regional panel. You've heard him in the news talk about, you know phase one, phase two, phase three and so I see regionally, and from listening to Bob Hagemann, I think regionally it's our Board of Legislators that are kind of like managing this for us and taking the guidance from the state and looking at our own personal numbers and what's happening with, you know, the disease and the number of people that are being impacted or not being impacted.

The other piece with this is what's going on with children and in the news. We didn't think we had a problem with COVID in children. Now there's like 90 kids that are impacted by this condition that's related to COVID. So that's kind of like another curve and people aren't sure what that means. I think they felt that schools eventually in phase four could open, but now if we have something that's related to kids, that's another whole dynamic we have to learn.

President Allen: I know there's a question from Kyle,

Kyle Gehrke: I was asked by a parent with someone in the senior class, if there is a plan or if it could be looked at to make a plan to redistribute their class funds back to the students, potentially? I guess this class has a lot of money saved up now they have no trip, they're wondering what's going to become of it.

Ms. Collins: Thank you Kyle, that's a good question and it forward to us last week and Steve is getting in touch with the, the Board's Auditor to see if that's possible.

Kyle Gehrke: Thanks.

President Allen: Thanks, that's a good question Kyle. Thank you. Thanks for Steve and Janes getting on. Steve, can you hear me?

Stephen Magovney: Yep, I'm here,

President Allen: When you put a report together for Jane this week, for the Board, Adam had a question about the budget. Could you also include in there, so the board can see it, in our weekly report what the senior class is for a balance?

Stephen Magovney: Yeah, I can do that.

President Allen: It doesn't have to be done tomorrow just by the end of the week. Thank you, and are there any other questions for Jane? Any questions for anybody, you know, at this point Scott, Sally, Ashleigh, Steve? Is there any other thing to come before the board meeting? Sally, everything's good on your end.

Sally Kohl: Yes it is.

Kristin Vaughn: I do have a question

President Allen: Sorry, go ahead Kristin.

Kristin Vaughn: Sorry I was asked about field use for the summer. Is that something that's going to be available to people or no?

President Allen: Based on, I think probably Jane is going to repeat me, but whatever the Governor's Executive Order, so, as of right now? No as until June 30, all public schools and facilities are closed. Jane?

Ms. Collins: I would agree with JW on that response. [Unreadable] the field was mowed, the new sod field once already and fertilized and it's growing really well, it looks good.

President Allen: It does look good. I've spoken to other people who recognized that it does look good.

Ms. Collins: The mowing was done at four inches high and according to the contractor who's responsible to mow it this year they will continue to mow that a little bit lower every time but it's not going to go much below three inches, I think, for the year.

President Allen: I'm glad you updated us on that.

Ms. Collins: The sign up front, if you want to know about that, they resumed work on the sign up front with laying the brick and we're going to get that installed as soon as possible. Once the bricks done, we're ready to have this sign installed and then calibrated so that we have the connections made with the building.

President Allen: Perfect. Any other discussion? Any other questions for the evening? Give us five seconds and I'm going to wind it up in case there is any lag.
