WHEREAS, Section 119-n of the General Municipal Law defines the term "municipal corporation" for the purposes of Article 5-G as a county outside the city of New York, a city, a town, a village, a board of cooperative educational services, a fire district or a school district; and

WHEREAS, Belleville Henderson Central School District (hereinafter sometimes referred to as "Participant") is a "municipal corporation" as defined above; and

WHEREAS, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

NOW THEREFORE, BE IT RESOLVED, that this Board hereby determines that it is in the interests of the Belleville Henderson Central School District to participate in the NYSMEC, and authorizes and directs the Superintendent to sign the Agreement/and or the Billing Schedule and Agreement for electricity on its behalf; and

BE IT FURTHER RESOLVED, that this Board authorizes the Administrative Participant (as defined in the Agreement) to prepare, advertise, disseminate and open bids pursuant to the General Municipal Law and to award, execute and deliver binding contracts on behalf of this Board for the purchase of electricity delivered to the delivery point of the local utility distribution company for the Participant's facility or facilities, on a firm basis, for this Participant to the lowest responsible bidder as is determined by the Administrative Participant at a price for such commodity electricity not to exceed \$0.0736 cents per kWh for a term of at least one year and no more than three years commencing May 1,2021, and other terms and conditions, all as may be determined by the Administrative Participant, or to reject any or all such bids; and

BE IT FURTHER RESOLVED, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

BE IT FURTHER RESOLVED, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

This Resolution shall take effect immediately.

WHEREAS, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May, 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

NOW THEREFORE, BE IT RESOLVED, that this Board hereby determines that it is in the interests of the Belleville Henderson Central School to participate in the NYSMEC, and authorizes and directs the Superintendent to sign the Agreement/and or the Billing Schedule and Agreement for natural gas on its behalf; and

BE IT FURTHER RESOLVED, that this Board authorizes the Administrative Participant (as defined in the Agreement) to prepare, advertise, disseminate and open bids pursuant to the General Municipal Law and to award, execute and deliver binding contracts on behalf of this Board for the purchase of natural gas delivered to the city gate of the local utility distribution company for the Participant's facility or facilities, on a firm basis, for this Participant to the lowest responsible bidder as is determined by the Administrative Participant at a price for such commodity natural gas not to exceed \$0.583 cents per therm for a term of at least one year and no more than three years commencing May 1, 2021, and other terms and conditions, all as may be determined by the Administrative Participant, or to reject any or all such bids; and

BE IT FURTHER RESOLVED, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

BE IT FURTHER RESOLVED, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

Kristin Vaughn: Move it.

Jane Collins: Title IX. There are some there were changes in the law. We've been waiting for the Erie I BOCES report. The sample policy came through. Since our last policy Scott and I have been

through training on this on the changes. And we also have Ashleigh and Steve who will be trained on the changes when we come back to December will provide you with a second reading to review.

President Allen: For the Board's review, there are meeting minutes from BOCES. Let's jump into reports. Mr. Magovney.

Mr. Magovney: Due to the audit, I do not have too much to report on.

President Allen: Understandable. We'll jump into I guess Ashleigh's than Scott's.

President Allen: Ashleigh's report is titled Administrative Coordinator's Report.

Clerk Notes: See attached report "Administrative Coordinator's Report".

President Allen: If everybody reads the last part, I think that is what we need to understand. Any questions for Ashleigh? (None)

President Allen: Mr. Storey, a plethora of donations?

Scott Storey: Yes.

President Allen. Good news that is positive.

Scott Storey: Yep. Before we get to that.

President Allen: Oh, I'm sorry.

Scott Storey: The January regions exams have been canceled. So our normal process is for all 11th graders to take English 11 regions exams in January, there is guidance out as it was last June for students to still be able to pass credit for regions exams and all that. So we'll make sure that process is followed as we did before.

Yes, Mr. Allen, you're right, we've gotten some donations recently. And so I just thought it'd be nice to add that to a little report. See attached report.

Kristin Vaughn: Did you get a lot of donations during spirit week?

Scott Storey: I know some came in, I didn't notice how many.

President Allen: So the Backpack Program is back up slow start

Scott Storey: It did. The first month of school we were quite low and then we did a solicitation of sorts through ParentSquare once that was up and running. It's been averaging 11 or 12 families or backpacks.

President Allen: Ms. Collins's report, we will start on the second page number eight. Is that correct?

Iane Collins: Yes.

So, at your table is this report from the NY Department of Health Interim Guidance on Mandatory COVID-19 Testing in Public and Non-Public Schools Located in Areas Designated as "Yellow Zones" Under the NYS Cluster Action Initiative.

So the State has gone through this process where they are looking at COVID of different communities. The worst cluster would be a red zone, a warning zone would be an orange zone and then yellow one would be a precautionary zone, and basically this presentation is about what if we become a yellow zone. If we become a yellow zone and we are open, then it will be required that we test 20% of our in school population in this memo talks about how the Department of Health will provide those to local designated areas to administer. So we couldn't not administer it, but perhaps public health good and so if that was the case that we would have to test 20% of the in school population every week and it's a different 20% to continue to remain open otherwise we would close until the zone changes from a yellow zone to no color. So right now, we're not in the yellow zone and well but we got this guidance today. So we'll explore how would we manage that, because in my opinion, if we can stay open. We should do everything we can to stay open. Okay. And I think it would be much easier for a small district like Bellville Henderson, we have, you know, to partner up with some place like public health to see if we could engage them in in doing testing, then the other part of that would be parents having to cooperate with having their child tested.

The most important thing I think in that part of the memo is that there's no cost. It's very important thing when parents have to pay \$30 or whatever the cost is. It's been hard on families so that's it in a nutshell. And I wanted to bring it to the Board. It's hot off the press today and we're going to be meeting with public health talk more about that, but I do know that Bellville Henderson is very interested in exploring the option of testing in house to be able to have our students to continue to come to school. So that's, that's one thing that goes into greater detail. I didn't want to read it all to you tonight.

I want you to know the capital outlay for 2021 is well on its way involves AC units. I believe in the auditorium cafeteria areas part of the original school and on your handout there tonight, you're going to see the process and push that's going to work.

State reimbursement of transportation costs as I shared with you the memo last week, which was very discouraging and the Governor said to schools, we want you to stay open. We want you to have your bus drivers ready to drive and take people places. We want them their income to continue.

Now, we are getting a memo from the state that says that school districts may not claim and receive state reimbursement for costs for transportation. When students were not coming to school hearing the closure last year. That's counter to what the governor told us is.

President Allen: This is significant. If I could interject, this is significant and it's on top of what you've heard Steve and Jane these last six months. We're getting aid but they're withholding 20%. We are getting aid, but they were only 20%. We take these things and compile on Top of what I believe, read some of the experts. What is what is ahead of us?

As far as financial issues. This is significant. We listened to our auditors present tonight about how you know your salary went up for your employees. But your employee retirement contributions and employee benefit contributions actually decreased, well how is all that possible, because the financial markets are doing so well.

Like, I remember when I first got here the percent of those was increasing 10 to 14% a year. And if that happens two to three years down the road and you are still playing catch up from what is we were told to do. Not that I want to paint a bad picture here, but I want everyone to understand the importance of this

Jane Collins: It is going to take an act of the governor to change this. And NYSSBA is joining forces with the New York State Council School Superintendents to lobby for that. So I want the Board to know that NYSSBA is working on that to get that to change.

President Allen: I hope Rural Schools is too.

Jane Collins: I'm sure Rural Schools will too, all those different organizations that were coming out.

But under the current law school districts may only submit claims for state reimbursement for actual costs and physically transporting to and from school. So basically the state aid unit says, hey, under the law. We can only do this, we cannot pay you for last year, the governor said to us last year we want everybody to continue to be paid.

So we did. Now, we now one year later, is when you collect that to run your school this year. And that's the transportation aid. Now they're saying the state is saying. But the law does not allowed. So in order for us to get this, the governor to pass a law to allow it.

President Allen: So that leads to number 4 right, think for the future.

Jane Collins: So, you know, we're not quite sure about that, but I would like the table that topic.

Jane Collins: And also go to the Open Meetings Law just so the Board should know that that was extended until December through third. So we have another 30 days of Open Meeting Law, which means we operate like this with virtual meetings for the public.

I'm recommending an executive session for personnel purposes and for legal purpose.

President Allen: We understand the executive session, is there any questions from Jane's report?

Kristin Vaughn: I do have some questions regarding the whole testing.

President Allen: The question on the floor is in regards to the yellow zone testing.

Jane Collins: Yes, yes.

Kristin Vaughn: So how does that rapid testing administered? Is that where you're swapping up the nose, or is that a quick mouth one?

Jane Collins: That hasn't been explained but what I will tell you personally is, my own personal experience is that it is a nose swab, nasal.

Kristin Vaugh: All right.

Jane Collins: But I don't know if there's more than one type and they have not defined that for us yet.

Adam Miner: Has New York State accepted those saliva tests as an accepted test?

Jane Collins: This has come up today. We are going to be meeting with public health in the near future. The county, Jefferson County Public Health are working with the Department of Health to study what this needs to look like. And from my perspective for Bellville Henderson, I'm going to be lobbying to see if we can get the 20% testing here.

And so we're going to have to study and communicate with parents what that will look like if we can accommodate the testing being done for our school, so that we can stay open. If we're open our buses are running our aid is flowing, open everybody's worked.

Kristin Vaughn: OK, so my other question is what if the parents refused to have their kids tested, you know, they refuse to be in that 20% and then also what happens if kids do test positive is school then automatically shut down anyway?

Jane Collins: The contact tracing will immediately go into play if there was a positive test. And that would be, you know, we look at who the person is near. And then from there, public health will take over and direct with who should be quarantined.

And the answer to your first question is, I would think that for my reading of this memo here it says for those who are in school, present. So if someone does not agree to the testing, they have to become a remote.

That's my initial response from what I know about the rules, because we'd have to go to remote and again we haven't sat down, we haven't met about this, but that's how I would see that.

Kristin Vaughn: So hypothetically, we do the testing hundred percent. I'm one of those parents that says, No, I don't want my child tested, right. So we're in a yellow zone at this time when they start the testing. Correct?

Jane Collins: Correct.

Kristin Vaughn: Yeah, we're not a yellow zone. You don't have to test. So we're yellow zone and say, No, I don't want my can test it. So my kid now has to go remote then we come out of the yellow zone. My child was allowed to come back. It doesn't matter too much.

Jane Collins: That's a good question. We'd have to look at that, you know, these are all guidelines that are being developed in interpreted by Jefferson County for Jefferson County and to my knowledge, we, we are not in yellow zone in this area.

Kristin Vaughn: Thank you.

Jane Collins: Now another piece that I heard today is St. Lawrence County has just gone to an emergency status. Has anyone heard this?

Just so you know, Jefferson County never left that we are all, we have continued to be in one so don't panic, that they have just done that they had to have left the emergency status, We never did. So just be aware of that.

President Allen: Good information.

Jane Collins: That happens at the county level so new that emergency status happens at the county level.

That concludes my report.

President Allen: Are there are other questions? How about generic questions than need to be researched?

So Jane has a personnel and legal matters. We have personnel on the agenda that has been tabled.

Because we don't have a coach, we need to get an update on that since our last meeting. So we have three things.




